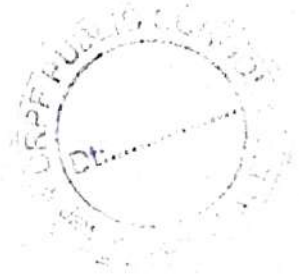

The Board has notified its revised Affiliation Bye-Laws, 2018 vide notification dated 18.10.2018. The Bye-Laws defines the framework within which the activities of the schools would be conducted to ensure that the spirit of value based education, fairness, and the rules are being followed in letter and spirit by the schools.

The Board has restructured the categories of schools affiliated with the Board as mentioned in rule 2.1 of Affiliation Bye-Laws -2018. Hence, all regular affiliated schools which earlier fall under regular affiliation category will now onwards treated under General Affiliation.
